JUDGMENT:

On the petition of widow in community and of sole heirs at law to be recognized and put in possession, the law and the evidence being in their favor:

IT IS ORDERED, ADJUDGED AND DECREED, that petitioner, MRS. ELIZABETH KAUL, widow of the late PHILIP NEFF, be recognized as the surviving spouse in community of the deceased, entitled, as such, to the one undivided half of the community property left by deceased below described, and to the usufruct of the other undivided half; and the petitioners, JOSEPHINE NEFF, the wife of JOHN BIEHLER; JOHN THEODORE GUSTAVE METE; JOHN MICHEL NEFF; LOUIS VM.
